

- Enhanced Shared Practices library
- Enhanced guideline criteria for sites implementing sameday PCI discharge
- And important updates:
 - for sites without onsite cardiothoracic surgery
 - for sites that perform device implants
 - to radiation safety and infection control standards

CCL incorporates the most recent ACCF/SCAl Consensus Document for Catheterization Laboratory Standards and other evidence-based science with quality initiatives.

Accreditation Designations Options

PCI-capable facilities with or without on-site cardiothoracic surgery may earn Cardiac Cath Lab Accreditation.

Optimization of the organizational platform to align dedicated personnel, operational program model, staff education, and service alignment.

Process improvement initiatives derived from outcomes and metrics related to the facility.

Protocols and policies for appropriate hand off, site management, patient and family communication and education, and discharge.



Continuous process improvement of all aspects of care. (Participation in the NCDR CathPCI Registry™ is required.)

Risk and readiness assessment through multidisciplinary screening processes and protocols to ensure safe and effective Cath Lab procedures.

Interdisciplinary care coordination and communication surrounding sedation, infection control, radiation safety, and universal timeout protocols.
