As we celebrated the American College of Cardiology's 75th Anniversary this past year, we were reminded that our journey is not just about the passage of time, but about the transformative impact we have had on cardiovascular care. From our humble beginnings in 1949 to today's global community of over 60,000 cardiovascular professionals, the ACC has been defined by a steadfast commitment to transforming cardiovascular care and improving heart health for all.

The story of the ACC is a testament to vision, resilience, collaboration and an unwavering commitment to excellence. Our members have been at the forefront of groundbreaking research, clinical advancements, transforming team-based care and advocacy efforts that have shaped modern cardiology.

Over the last year we were able to honor this legacy, while also charting an ambitious course for the future. Among the highlights, we launched our next Strategic Plan that involves continued focus on our Strategic Pillars, as well as several new major initiatives that will ensure we are able to continue to serve as the professional home for cardiovascular clinicians for another 75 years and beyond.

As part of this effort, we doubled down on our commitment to being both an early adopter of emerging technologies - from artificial intelligence to big data and digital health solutions - and a convener of stakeholders and partners like MedAxiom to identify innovative care transformation solutions that are not only cutting-edge but also practical and accessible. In addition, we continued to optimize our NCDR registries and ACC Accreditation Services, ensuring that hospitals, health systems and clinicians have the tools needed to harness the power of their data to drive meaningful change.

Innovation without equity is progress without purpose, and the ACC also remained steadfast in its commitment to dismantling barriers and solving for health equity. Our goal is to ensure that innovation serves as a bridge to care transformation and better health outcomes, rather than a barrier dictated by geography or socioeconomic status.

We also continued to invest in developing the next generation of cardiovascular professionals through programs such as the Sandra J. Lewis Mid-Career Women's Leadership Institute, the Wael Al Mahmeed Dedication to Young Leaders, the ACC Leadership Academy, the Emerging Faculty Program, and our Young Scholars and Internal Medicine programs. We are also fostering global mentorship and expanding initiatives like the Hani Najm Global Scholar Award and the William A. Zoghbi International Research Award to support research and education in low- and middle-income countries.

Cardiovascular disease knows no borders, and neither should our solutions. As such, accelerating our global impact was another important part of our work this last year. Collaborations with our Global Chapters (now numbering 43 with the addition of the Ireland Chapter), international societies and cross-disciplinary educational initiatives ensured we were sharing the latest science and innovations and localizing education around the world.

Additionally, the ACC continued with its critical role of advocating for policies that protect patient access, support workforce sustainability and reduce the global burden of cardiovascular disease. In 2024, we continued our advocacy work at the state, federal and global levels, ensuring that the voices of our members and patients were heard.

The need to address clinician well-being, the workforce crisis, and the health and growth of our Member Sections also remained key. We championed policies promoting workforce sustainability, along with safe and supportive work environments. We also reinforced the benefits of dyad leadership and multi-disciplinary care and stressed the need to leverage the strengths of the entire cardiovascular care team in order to shape a profession that is both resilient and inclusive.

Education and actionable knowledge remained central to our work. We pushed forward with our efforts to create a new, independent American Board of Cardiovascular Medicine, in collaboration with the broader house of cardiology. Our live meetings like the Annual Scientific Session, the MedAxiom CV Transforum and our Valentin Fuster Cardiovascular Symposium continued to set the bar for scientific meetings. Our Certified Cardiovascular Knowledge Examination for NPs/PAs and clinicians outside the U.S., as well as our SAP products and Collaborative Maintenance Pathway also provided cardiovascular clinicians with the means to showcase both their cardiovascular knowledge and their commitment to staying on top of the latest advances and treatments.

On the quality front, collaboration with the American Heart Association to optimize clinical guideline development remained a cornerstone of our efforts to provide actionable knowledge that improves care worldwide. We also expanded our own library of clinical guidance to address new and emerging areas of cardiovascular medicine.

Looking ahead, sustaining our mission for the next 75 years will requre a strong, adaptable organization. As we embark on the path forward, we do so with a clear vision: to create a world where science, knowledge and innovation optimize patient care and outcomes. Our collective efforts will shape the future of cardiovascular medicine and ensure a legacy that lasts for generations to come.

We thank you-our members, partners and supporters - for your unwavering dedication to the ACC's Mission. Together, we will continue to push boundaries, drive innovation and build a future where every heart is healthier and every life is longer.



# **IMPACTING HEALTH POLICY**



In 2024, ACC's advocacy efforts centered on establishing sustainable Medicare payment practices, care transformation, strengthening the clinician workforce and expanding access to care for all. Through strategic action on these priorities, ACC achieved key policy wins that benefit both cardiovascular clinicians and patients. The following (in no particular order) are the 10 biggest advocacy accomplishments of the year.



#### **PROGRESS ON LONG-TERM MEDICARE REFORM**

The ACC continues to push for legislative solutions to foster longterm, sustainable Medicare payment reform, and strongly supported the Strengthening Medicare for Patients and Providers Act (H.R. 2474). The ACC also submitted formal comments to the Centers for Medicare and Medicaid Services (CMS) voicing opposition to the continued cuts, and provided comments on telehealth policy, new atherosclerotic cardiovascular disease codes, global payment policy accuracy and the transition in the Merit-based Incentive Payment System.

#### **GROWING BIPARTISAN SUPPORT FOR PRIOR AUTHORIZATION REFORM**

The Improving Seniors' Timely Access to Care Act (S. 4532/H.R. 8702) secured majority bipartisan support with 59 Senate and 229 House co-sponsors. ACC State Chapters also secured key wins in prior authorization reform. The Maryland Chapter helped pass a new bill preventing insurance companies from abusing existing prior authorization laws, and the New Jersey Chapter also helped pass a law mandating insurers publicly disclose prior authorization criteria and approval/ denial statistics.

#### **TELEHEALTH FLEXIBILITIES FOR CARDIAC REHAB**

The ACC continues to prioritize making telehealth flexibilities permanent. The College successfully advocated for the extension of direct supervision of cardiac rehabilitation via telehealth and permission for practitioners to use their office address rather than their home address when providing telehealth services from their home through 2025.

#### **BOLSTERING** THE CLINICIAN WORKFORCE

A paper led by Senate Finance Committee Chair Ron Wyden (D-OR) outlined potential Graduate Medical Education (GME) policy expansion, calling for an overall increase in the number of Medicare-supported slots and strategies to increase slots for specialties and geographic areas with the greatest need. The ACC supports the Resident Physician Shortage Reduction Act (H.R. 2389/S. 1302), which would add 14,000 Medicaresupported GME slots, and gained nearly 200 bipartisan co-sponsors in Congress.

#### CHAMPIONING **ACCESS TO CARE** FOR ALL

In 2024, ACC Advocacy championed expanded AED access in schools, continuing to work with the National Football League's Smart Heart Sports Coalition. ACC State Chapters also played a pivotal role in passing comprehensive AED access legislation in seven states this year, including Georgia and Tennessee. Other legislative victories included passage of the Cardiomyopathy Health, Education, Awareness, Research and AED Training in the Schools (HEARTS) Act of 2024 (H.R. 6829) in the House, and the Congenital Heart Futures Reauthorization Act (H.R. 7189) that was signed into law in November.



# ACC LEGISLATIVE CONFERENCE 2024

More than 470 cardiovascular clinicians took part in the 2024 Legislative Conference, participating in more than 250 meetings with lawmakers and their staff. Following the conference, ACC Advocacy saw a 30% increase in signatories for the Medicare payment relief letter circulating in the House.



#### HEARTPAC: FORGING CONNECTIONS WITH LAWMAKERS

HeartPAC continued to support congressional champions of cardiovascular care, ensuring that issues like bolstering the clinician workforce, advancing prior authorization reform and maintaining critical telehealth flexibilities are prioritized. In the 2024 election, over 93% of HeartPAC-supported congressional candidates won their races, and 96% of HeartPAC funds supported winning campaigns.



#### BANNING NONCOMPETE CLAUSES

Noncompete and restrictive covenant legislation was prominent in several state legislatures in 2024, with multiple states attempting to ban these agreements for health care professionals. The ACC Maryland Chapter won a long, hard-fought battle by passing H.B. 1388, severely restricting most noncompete agreements. Additionally, ACC Chapters in Florida, New York, Oregon and Pennsylvania focused their advocacy efforts on eliminating these agreements. Pennsylvania was the only other state to successfully pass noncompete restrictions this legislative session.

#### THE TRANSITION TO VALUE-BASED CARE

The ACC remains dedicated to promoting the transition to value-based care for cardiovascular patients, holding its sixth annual Value-Based Care in Cardiology Forum. The Forum gathered clinicians, health systems, payers and other stakeholders to facilitate the implementation of models that prioritize high-quality care, inspiring meaningful discussions, innovative ideas and practical examples of collaboration between primary care and cardiology through incentive-based arrangements.

# EXPANDING PAYER COVERAGE

The ACC joined the Heart Rhythm Society in leading a joint letter encouraging energy-agnostic coverage for ablation, emphasizing the importance of clinician discretion in patient selection. Major national payers including Aetna, Cigna and Elevance Health increased their coverage in response. The ACC also joined a multisociety letter advocating for appropriate coverage for IVUS and atherectomy used to treat peripheral artery disease in lower extremities. Policy changes followed from Aetna, Humana and prior authorization vendor EviCore.


#### STRONGER TOGETHER

#### **FOSTERING THE FUTURE**

The ACC is committed to fostering future cardiovascular leaders and offeres complimentary membership to students and residents.

#### PROVIDING MENTORSHIP

The ACC's Cardiology Applicant Mentorship (CAM) Program continued to grow this year, pairing ~300 residents with ~150 FIT mentors to conduct mock interviews and providing resume assistance and leadership training. Founded in 2021, CAM has expanded to become a holistic resource for internal medicine residents who are applying to general cardiology fellowship.

To date, the program has provided assistance to 1,000+ residents and engaged more than 400 FIT leaders.

#### **EXPANDING OUR GLOBAL** CHAPTER NETWORK

ACC welcomed Ireland as our 43rd International Chapter, thanks to the efforts of the Irish Cardiac Society, which also celebrated its 75th anniversary year in 2024. The new Chapter will strengthen the exchange of science and knowledge between Irish cardiologists and the ACC as we work to transform care worldwide.

#### PARTNERING TO PROVIDE **ACCESS TO AEDS**

In addition to ACC's efforts to improve access to AEDs in the advocacy space, the College this year expanded its suite of membership benefits to include a partnership with Zoll, offering exclusive pricing on their AED 3 defibrillator with an active membership. The partnership builds upon our existing affinity partner benefits that include discounted medical professional liability insurance, employment contract review services and more.



#### PROVIDING COMMUNITY EDUCATION THROUGH CHAPTER SECTION GRANTS

Chapter Section Grants continue to provide important funding for innovative collaborations between ACC Chapters and Member Sections. For example, a collaboration between the ACC Alabama Chapter and the Advanced Career Professionals Member Sections connects cardiologists to conduct outreach with ethnically diverse church congregations for community building and learning related to building heart-healthy habits. The ANNO: Engaging Senior and ACC Members in Partnership to Resolve Disparities in Cardiovascular Health and Longevity in the State of Alabama, is a great example of Chapter and Member Section efforts to educate rural communities around nutrition, exercised and heart health.

#### REDUCING FINANCIAL BARRIERS TO MEMBERSHIP

ACC believes that making member benefits more accessible strengthens our ability improve outcomes for our patients by encouraging knowledge sharing, collaboration and quality care delivery.

Starting in 2024, registered nurses and allied health professionals, like occupational therapists, genetic counselors, dieticians and cardiovascular techs, can access ACC's clinical and networking tools at a discounted rate. Members will also receive complimentary membership in the Cardiovascular Team Member Section, where they'll find a new Allied Health Professionals Work Group designed to elevate their perspective.

ACC also expanded its tiered early career dues program to include an additional year of discounted membership to cardiovascular physicians just beginning their career. Under the new program, early career physicians receive four years of discounted national chapter dues-and don't have to pay full dues until five years removed from training.

# **INSPIRING** TOMORROW'S LEADERS

#### **GROWING ACC'S INTERNAL** MEDICINE PROGRAMS

The ACC's Internal Medicine Programs continued to grow in 2024, with **272 participants joining the cohort-based program** designed to connect individuals traditionally underrepresented in medicine with mentors, peer support and resources to understand career opportunities in cardiology.

Beyond mentorship, the cohort has offered a supportive community that understands and relates to my experiences. Whether it's professional advice on handling LGBTQ+ patients with unique needs or personal support, the responsiveness and mutual respect within our community are a testament to its strength. This solidarity inspires me to support incoming trainees and ensure that this culture of support and respect continues.

#### STRENGTHENING THE WORKFORCE OF THE FUTURE

More than 100 high school and college students participated in ACC's Young Scholars program in 2024, an initiative designed to introduce the next generation to the field of cardiology. Sixty-eight students also attended Camp Cardiac in December, for an immersive deep dive into the specialty. Attendees connected with mentors and learned practical, hands-on skills like CPR/AED and point-of-care ultrasound training.

#### ADVANCING GLOBAL HEART HEALTH

Sergio Henrique Rodolpho Ramalho, MSc, PhD, FACC, became the first recipient of the William A. Zoghbi International Research Award—and received \$25,000 in funding to support his work focused on Artificial Intelligence in Electrocardiographic-Based Triage Protocols: Impact on the Time to Diagnosis, Time to Treatment Initiation and on Clinical Outcomes. Three Hani Najm Global Scholar Awards were also distributed, providing the awardees with an opportunity to elevate their training by participating in an observership program at the Cleveland Clinic.

#### EMPOWERING FUTURE LEADERS IN CARDIOLOGY

The future of cardiology is bright, with the growth of programs dedicated to cultivating tomorrow's leaders, educators and researchers. From ACC's Clinical Trials Research program kicking off its fourth cohort, to the Wael Al Mahmeed Dedication to Young Leaders convening future leaders from more than 60 countries, ACC's leadership development programs are equipping professionals with the skills, insights and global networks necessary to drive transformative advancements in cardiovascular care.

The second cohort of the Sandra J. Lewis Mid-Career Women's Leadership Institute convened 22 women at Heart House for mentorship and career development. To-date, the program has impacted the lives of 44 mid-career women.

The Global Leadership **Institute** assembled future leaders from 30+ international chapters to learn vital skills from ACC mentors as part of the Wael Al Mahmeed Dedication to Young Leaders programs.

The **Emerging Faculty** Program welcomed 24 clinicians to build their skills as future educators this year. The program has inspired and ignited the careers of 300+ learners since its founding, thanks to the generosity of ACC Past President, Michael J. Wolk, MD, MACC, and the Michael Wolk Heart Foundation. The Clinical Trials Research program convened 51 learners as part of its fourth cohort this year for meetings in June and November. This vear, in collaboration with the Association of Black Cardiologists, 28 of the learners participated as part of Project REACH

(Research, Equity and Access for Cardiac Health), an initiative designed to address existing

disparities in structural heart clinical trials work.

# ADVANCING PATIENT CARE & ACCESS





In collaboration with Morehouse School of Medicine and with the generous support of Johnson and Johnson, the ACC's Atlanta Heart Health Fair leading up to ACC.24 was a huge success.

The health fair provided an opportunity for the community to learn more about heart disease risk factors like peripheral artery disease (PAD), peripheral vascular disease (PVD), hypertension, and high cholesterol - which often disproportionately impact Black and Hispanic/Latinx communities. Local health care providers, ACC leaders and other experts provided education on these risks and best practices for making healthier lifestyle choices. **During the fair, 87 members of the Atlanta community were screened for PAD.** 

# IMPROVING CV CARE IN RURAL COMMUNITIES

The ACC, in partnership with the JF Maddox Foundation, kicked off the Rural Cardiovascular Health Initiative (RCHI) in early 2024. The 12-month pilot project taking place in Hobbs, NM, is designed to create and test an action module that can be used more broadly to improve cardiovascular health in rural communities nationwide.

The three key goals of RCHI include:

- Improving HOSPITAL cardiovascular care through the integration of advanced cardiovascular training at Covenant Health Hobbs Hospital.
- Engaging COMMUNITY members by deploying Community Health Workers trained to provide cardiac-specific patient education.
- Increasing community-wide awareness of cardiovascular risk factors through PATIENT-centered materials.

We know that people living in rural communities have many challenges in accessing many things that affect heart health, including reliable health care and other resources to support healthy lifestyles. Our family's foundation, the JF Maddox Foundation, is focused on improving life in southeastern New Mexico, so there was a natural connection between their mission and the RCHI.



#### **PROVIDING FAMILIES ACCESS TO FRESH PRODUCE**

The ACC Foundation and the ACC's Caring Hearts Initiative joined forces to raise funds to provide families experiencing food insecurity with access to fresh produce during Hunger Action Month this September. The fundraising program provided fresh produce to families living in four communities: San Jose, CA; Phildelphia, PA; Buffalo, NY; and Camden, NJ. To date, the Caring Hearts program has distributed more than \$33,000 in food incentives in these communities

#### PRODUCING A FRAMEWORK FOR **ACHIEVING HEALTH EQUITY**

In September 2024, the ACC Board of Trustees Task Force unveiled a comprehensive framework to advance health equity in cardiovascular care. The framework emphasizes a multifaceted approach, including targeted interventions, robust data analytics, enhanced stakeholder collaboration and strategic policy advocacy.

The plan, published as part of a focused Health Equity issue of JACC: Advances, is centered around the following six "Health Equity Domains": 1) health care data, science and tools; 2) workforce diversity; 3) education and training; 4) membership partnerships and collaborations; 5) community advocacy and policy; and 6) clinical trial diversity. It also outlines a blueprint for implementing health equity and highlights future work necessary to achieve key goals.

#### **COLLABORATING** WITH STAKEHOLDERS

Improving patient access to care can't be done alone. ACC is committed to advancing solutions with stakeholders across cardiology, health systems, government and industry.

Current participants in the Industry Advisory Forum, an opportunity for bi-directional dialogue and exploration of areas where collaboration and partnership with industry stakeholders and others could bring about real change in the prevention and treatment of cardiovascular disease.

#### **ADVOCATING FOR WOMEN'S HEALTH** ON CAPITOL HILL

Roxana Mehran, MD, FACC, Sharonne Hayes, MD, FACC and other ACC leaders spearheaded an event on Capitol Hill and connected with members of Congress to promote awareness of women's heart health and reducing gender disparities in care.

# TRANSFORMING GLOBAL HEART HEALTH

Under the strategic leadership of the Assembly of International Governors, the ACC continued to advance global collaboration and initiatives forward to transform the future of global heart health.

#### IMPACTING CARE WITH NCD ACADEMY

The NCD Academy launched three new courses in 2024, addressing Foundational Concepts in Care Integration, HIV and Lifelong Care, and Vaccine Preventable Diseases. The redesigned website now offers more resources, including Quick Access Content - a collection of introductory videos that cover a range of key health topics, including health equity and social determinants of health in NCDs, flu, metabolic diseases, digital health solutions, and more. #### SHAPING THE FUTURE OF **OBESITY MANAGEMENT**

The Global Obesity Masterclass continued to improve care for patients in critical regions across four countries in the Latin America, Middle East, and Asia Pacific regions. In 2024, its new Global Obesity Symposium attracted 100+ delegates from across the Middle East for a deep dive into UAE cardiometabolic guidelines, new obesity treatments, and more.

#### **ADVANCING STEMI** CARE GLOBALLY

The impact of ACC's Global Heart Attack Treatment Initiative (GHATI) was highlighted this year in a JACC: Advances publication outlining the transformative potential of quality improvement metrics in low- and middle-income countries. Using data from the initial phase of GHATI, the study analyzed 3,914 STEMI patient records and observed a 2% improvement in both combined endpoints (shock; arrest before or after intervention; final ejection fraction <40%; survival at discharge) and survivorship. With 74.8% of patients receiving device intervention within 90 minutes, 94.2% undergoing reperfusion therapy, and 91.8% adhering to guideline-directed care, these results underscore the initiative's impact and pave the way for ongoing advancements in acute cardiac care through collaborative, data-driven strategies. To date, has collected records from 54 participating sites in 24 countries.

# **EMPOWERING** LIFELONG LEARNING

In 2024, the ACC advanced its commitment to excellence in cardiovascular education by growing its programs designed to help clinicians translate the latest scientific discoveries into practical, clinical applications. From joining the House of Cardiology and formally applying to create a new Board for cardiovascular medicine to providing new professional credentials and growing our library of digital content, we helped learners advance their knowledge to optimize care and outcomes.

#### CREATING AN INDEPENDENT BOARD OF CV MEDICINE

As the field of cardiology has evolved into its own distinct specialty, separate from internal medicine, the House of Cardiology felt strongly that having a separate and distinct certifying Board was necessary for sustaining professional excellence and effectively caring for cardiovascular patients. In 2024, the American College of Cardiology, the American Heart Association, the Heart Failure Society of America, the Heart Rhythm Society and The Society for Cardiovascular Angiography & Interventions submitted a formal application to create the American Board of Cardiovascular Medicine (ABCVM) under the American Board of Medical Specialties (ABMS).

#### INNOVATING TO IMPROVE QUALITY CARE

This past year, NCDR built upon its optimization plan and launched enhanced dashboards for all registries, providing robust visualizations and a faster, more dynamic data customer experience to support facilities, health systems and clinical care teams in their goal of optimizing cardiovascular patient care and outcomes.

New features include streamlined navigation, bookmarking custom views and the ability to export to PowerPoint. The release of these dashboards provides the NCDR community with a modern dashboard product that is intuitive, flexible and actionable.



New additions to the NCDR family of registries have also come about over the past year, spurred by up-and-coming trends in the cardiovascular care landscape. In February, the ACC unveiled the CV ASC Registry Suite - NCDR's newest registry. The CV ASC Registry Suite offers data-driven insights on cardiac procedures performed in the ambulatory surgery setting through a first-of-its-kind dashboard.

Registry participants have access to benchmark data from ACC's CathPCI Registry and EP Device Implant Registry for elective patients, in addition to benchmarks and comparisons, including procedures data, hospitalization rates, emergent transfer rates, medications, efficiency rates, adverse events and bleeding events performed only in ASCs.




## **REVENUE**
