Dear Representatives Thompson, Schweikert, Balderson, and Matsui:

On behalf of the American College of Cardiology (ACC) and our clinician members dedicated to advancing cardiovascular care, we write to express our strong support for the ***Creating Opportunities Now for Necessary and Effective Care Technologies (CONNECT) for Health Act of 2025 (H.R. 4206)***. Your legislation will expand coverage of crucial telehealth services through Medicare, make permanent COVID-19 telehealth flexibilities, improve health outcomes, and make it easier for patients to connect with their doctors.

This critical legislation will advance the integration and accessibility of telehealth services, ensuring that patients receive high-quality, timely, and efficient cardiovascular care. The ***CONNECT for Health Act*** recognizes the evolving landscape of health care delivery by removing outdated geographic restrictions on telehealth services, expanding originating sites, and enhancing provider eligibility to furnish telehealth care under Medicare. These measures are instrumental in addressing barriers to care, particularly for patients in rural and underserved areas who face challenges in accessing cardiovascular specialists.

The expansion of telehealth under the ***CONNECT for Health Act*** will further support innovative approaches to remote patient monitoring and virtual consultations, fostering continuity of care and improved patient outcomes.

The ACC has long advocated for policies that leverage digital health technologies to optimize patient-centered care. The ***CONNECT for Health Act*** is a significant step toward a more inclusive and efficient healthcare system, empowering patients and providers with the tools necessary to improve cardiovascular health and overall well-being.
