Document does NOT become formal College policy and is NOT published in JACC.</i>	<p>Document either does <b>NOT</b> meet the endorsement criteria listed above <u>or</u> ACC cannot endorse all the content; however, it does meet ALL of the following criteria:</p> <ul style="list-style-type: none"> <li>The document was commissioned by an organization (not a group of individuals)</li> <li>Author RWI will be published in the final document</li> <li>Sponsoring organization has given ACC adequate time (4 weeks) for consideration by CPAC and relevant committees</li> <li>The document does not contradict current ACC policy documents.</li> </ul>	Science and Quality Committee (SQC)	Clinical Quality Approval Committee (CPAC)	<ul style="list-style-type: none"> <li>ACC rep name may appear in author listing.</li> <li>Document may reflect ACC <i>Affirmation of Value Statement</i> but may neither include the ACC name in the title of the document nor indicate "endorsement".</li> <li><b>NOT published in JACC</b> (unless requested by JACC Editor-in-Chief).</li> </ul>
<b>NO official participation</b> <i>The document did not meet the above criteria for partnership, endorsement, or affirmation.</i>	SQC chair elects not to send document to CPAC for formal consideration because it does not meet criteria in categories above CPAC voted <b>NOT</b> to approve, endorse, or affirm the document content.
